# 1.5 Days Certified Management Consultants (CMC) Mentorship Program for DBA/PhD candidates or Certified / Chartered / Management Professional

The Mentoring Program of IMCHK was developed in 2017 to help IMCHK members to settle into the management consulting industry effectively. The CMC Mentorship Program is a new extension of Mentoring Program in 2020 to promote IMCHK mentoring and CMC recruitment. Doctorate candidates or chartered / certified / Management Professional may apply to join the CMC Mentorship Program to earn their CMC qualification. They may develop their second profession in management consultancy to extend their career development path. The candidates will be assigned a mentor (senior CMC) to guide their CMC competency development, which includes short training, case study, interview and ethical test within 6 to 12 months.

# **Objectives:**

- Recruiting potential CMC candidates to train up management consultant professionals in Hong Kong and the Greater Bay Area.
- Speeding up the development of CMC professionals of IMCHK and ICMCI in regional areas.
- Establishing effective career development paths and promoting the management consultancy industry.
- Helping professionals, experts and management to develop their second profession in management consultancy.

# **Admission Requirement:**

- 1) Holding a bachelor degree from a recognized university;
- 2) Working in management or consultant for 3 years (internal or external consultants);
- **3)** DBA or PhD candidate of a recognized university, Chartered / Certified / Management Professional (e.g. Accountant, Engineer, Financial Planner, IT Professional, etc.)

- **2.3)** Consulting Process and Engagement *client's requirement, proposal, study, recommendation, and reporting*
- **2.4)** CMC Common Body of Knowledge consultancy, organizations, management processes, skills & knowledge, business of consulting
- **2.5)** CMC Competence Framework client business insight, consulting business insight, functional specialization, engagement Management, ethics and professionalism, analytical skills, personal interaction, continued learning and development.
- **2.6)** Consulting Case Selection and Presentation Preparation case selection, study, review, outline and determination.
- **2.7)** Basic Principles of Code of Professional Conduct standards of service to the client, Independence, objectivity, integrity, and responsibility to the profession.
- 3) Join (1/2 day) activities Conduct test, interview, and CMC award
- **3.1)** Code of Conduct Test (10 multiple choice questions)
- **3.2)** Consulting Case Presentation and Interview (10 ~ 15 minis)
- **3.3)** Registration and Payment of Annual Subscription for CMC membership (1,900 HKD)
- 3.4) CMC Certificate Award



# **CMC Mentorship Fee:**

a) Apply and join the full/professional member (MIMC) of IMCHK

Application Fee: HKD 800

Annual membership Fee for MIMC: HKD 1,900 (entry after Jul, HKD 950)

- b) Join the CMC Mentorship ProgramApply and join IMCHK CMC Mentoring Program (free of charge)
- c) Attend the 1 days CMC Certification Training (e.g. Consulting, ISO20700, case study, and code of professional conduct)

  CMC Certification Training will be conducted by IMCHK or IMCHK partnered trainers (other training institute), Training Fee: HKD ~ 4500
- d) Attend 1/2 day ethical test, case presentation and interview
- d.1) Join and pass the ethical test (10 multiple choice questions)
- d.2) Join and pass case presentation (present and interview to 3 examiners in 1 hour) Certification, Presentation and Ethical Test Fee: HKD 3,500
- e) Register and pay annual subscription for CMC
