#### ISO 20700:2017 Training for CMC Members

The ISO 20700:2017 Guidelines For Management Consultancy Services training was arranged on 28/11/2020 (Saturday) 0900-1300 / 4 hours (via Zoom). A total 20 CMCs joined the training. The training aims to improve the transparency and understanding of consultancy assignments between management consultants and their clients. This was a half-day training on ISO 20700:2017 Guidelines for Management Consultancy Services which was specially organized by IMCHK for Certified Management Consultants. The Program outline included:

- 1. Introduction by Chairman (20 mins)
- 2. Small Corp Case Review & Q&A (45 mins)
- 3. Grouping into 3 small teams (5mins)
- 4. Break (15 mins)
- 5. Medium Corp Case group discussion (60 mins)
- 6. Group Presentation & Q&A @15mins x 3 (45 mins), Presenting key point samples (15mins)
- 7. Closing by Vice-Chairman (20 mins)






#### **IMCHK Annual General Meeting (AGM) 2020**

#### Certified Management Consultant (CMC) Competence Framework (CMC002a)



CMC Competence Framework cover the professional competences that management consultant should develop

(A) Client Business Insight - Understands the internal and external factors impacting on the project

**A1 Client understanding** - Understands core business structures, processes, management and disciplines of client

**A2 Client business knowledge** – Studies the client's business and industry

**A3 External awareness** - Analyze the external impact (e.g. political, economic, social, technological, legal and environmental factors)

(B) Consulting Business Insight - Understands the management consultancy environment and its commercial aspects

**B1 Consultancy business knowledge** - Studies the structure and operation of consultancy (e.g. cash flow, profit and loss, intellectual property, risk management, local laws and regulations)

#### **B2** Commercial aspects of assignments -

Commercial awareness/participates, and understand the situation of job assignment (e.g. management, resource, skills, capability, pricing, scope, risk, negotiation) **(C) Functional Specialization -** Recognized as an expert in own discipline

**C1 Functional knowledge and skills** - Builds technical expertise through education, qualifications and work experience

#### C2 Sectorial knowledge and experience -

Demonstrates knowledge of the sector in which work is carried out

(D) Engagement Management - Determines the scope of client assignments. Manages client and other stakeholders' expectations. Engages expertise of others where appropriate

### ISO20700:2017 for Management Consultancy Services

ISO 20700:2017

#### **Certified Management Consultant**





This important role of management consulting in a modern economy and society has been the arena of CMC-Global for more than 30 years.

As part of its role as the self-regulatory body of the management consulting profession, CMC-Global (ICMCI) took the lead in initiating the production of the ISO 20700 standard. This initiative came from its values to promote innovation, differentiation, ethical behaviour, service excellence, and continued improvement, with the customer focus as the core, to enhance transparency and understanding between clients and management consultancy service providers.

The contributions of CMC Global lead to a modern standard that **meets the requirements of clients** as well as the management consulting industry by **re-enforcing good consulting practices** and **ethical behavior** among practitioners, while focusing on outcomes by defining state of the art successful assignments and accommodating the different cultures, size of projects, and approaches to consulting.

The **focus on clients** was with the purpose of providing them with a tool to assist in identifying and selecting professional providers that demonstrate good professional practices, as well as means to evaluate services received. This provides clients of management consultancy services with the assurance of professional behaviour and enhances trust that is based on a systematic scheme for consulting.

In order to provide practical and hands on support for management consultants in demonstrating their work according to the ISO 20700, CMC-Global has also developed a **self-declaration checklist** to the ISO 20700:2017 Guidelines for management consultancy services.

CMC-Global makes checklist in a "**Train the Trainer**" training provided to all its **IMCs** to accredit them to provide the training to their Management Consultants (MCs) and Certified Management Consultants (CMCs), with a certificate issued by the **IMCs** and **ICMCI**.

The self-declaration list (comprising of approximately 50 questions) accommodates all sizes of projects ("Small", "Medium", "Large/Complex") according to each consulting phase and ensures common understanding between provider and the recipient of the service.
